SEMTEX URBAN CHALLENGE Event Waiver

I, undersigned Participant of the SEMTEX Urban Challenge Event (hereinafter "the Event"), which is organized by Events 4 you, z. s., IČ 03675131, Praha 4, Mikuleckého 1311/8, PSČ: 147 00 registered in the Federal Register maintained by the Municipal Court in Prague, Section L, File 61775 (hereinafter „organizer“) accept and am aware that the Event is a test of my physical and mental abilities and involves specific and considerable risks (such as a risk of injury or other health damage, death or property damage). By signing this statement, I confirm and accept willingly and freely all risks associated with my participation in the Event. I hereby confirm that I am healthy and in a good physical shape. Furthermore, my decision to participate in the Event is not against any medical advice.

I, acknowledge, accept and agree with the following points regarding my participation on the Event:

- a) I agree to abide by all applicable rules of the Urban Challenge event.
- b) I agree to inspect the course of the race, its facilities, equipment and all associated spaces before the race. Should I find any of the aforementioned spaces dangerous, I agree to inform the Organizer.
- c) I waive my rights to any legal claim or liabilities, though otherwise conceded to a participant by the law of the Czech Republic, in case of harm to health, disability, death or property, resulting from my participation in the Event towards following subjects or legal entities: Events 4 you, s.z, sponsors, race directors, employees and volunteers, even if these claims, losses or liabilities were to be caused by negligence or failure of any of the subjects aforementioned.
- d) I acknowledge the race will pass off along regular traffic and that I am solely responsible for the risks of running and participating in the Event. I also assume all risks associated with competing in Urban Challenge event, including falls, contact with other participants, the effects of weather, state of the roads and crossings, water obstacles and danger potentially caused by volunteers and visitors.
- e) I agree not to prosecute any of the subjects or legal entities aforementioned in clause (c) regarding rights and responsibilities about statements, losses or liabilities, which I renounced in this waiver.
- f) I agree to reimburse the aforementioned subjects and legal entities provided in clause (c) for such behavior or inactivity that would cause harm or damage to the aforementioned subjects provided in clause (c).
- g) I accept that my starting fee is not refundable in any cases.
- h) I agree with sending me detailed information about the Event by e-mail, which I wrote in registration form. More precisely is my responsibility to look for the information by myself on the website www.urbanchallenge.cz. Organizer needs to accomplish his information commitment about further information about Event.
